


Dear ECGS Members,




Subject: Harriet R. Goodrich Salem Hospital Training School Class of 1896. Salem, Mass.

Letters From Our Volunteers Charlotte Republican Newspaper Dated June 27, 1862

Capt. Fowler, of the "Eaton Rifles" ---- Co. H., 6th Mich. Inf. --- has resigned in consequence of sickness, and has been granted a discharge. He arrived home on Wednesday, and from him we have the following particulars:

The head-quarters of the regiment was at Baton Rouge. The following members of Co. H. were in the hospital at New Orleans: O. Hadley; W. R. Whitney; Henry B. Dow; Fife-Major Carlos Spalding; Chas. Vickery; E.P. Dwight; Geo. Bennett; S. Lampson; A. Lake; Wm. Johnson; A. P. Green; C. Hollenbeck.

Henry B. Dow had been very sick, but was better; S. Lampson and Maj. Spaulding would probably soon be discharged; and A.P. Green was dangerously sick.

Capt. F. came to New York on the steamer Connecticut. Mr. Bradshaw, an officer of the U. S. War Steamer Mississippi, jumped overboard, on the passage, in a fit of insanity. Col. Jones of the Massachusetts 26th, who marched through Baltimore April 19th 1861; Maj. Strong, chief of Gen. Butler's staff; and Lieut. Harold of Butler's staff, came home on the Connecticut, sick.

The Ship touched at Mobile. Fort Morgan would not be attacked until the return of the fleet from Vicksburg.

Capt. F. has a chronic diarrhea, and has had a fever, by which he is much reduced.

A late letter from a member of the "Rifles," states that 2d Lieutenant Wm. S. Trask had been elected Captain of the Company, J. H. Brainard taking the place of 2d Lieut. Oliver Kinne, 2d Seargeant, died with dysentery. W. H. Lamb, and H. N. Finch was slightly wounded.

It is with peculiar pleasure we hear of the selection, by the company, of Wm. S. Task to the position left vacant by the resignation of Capt. Fowler. Mr. Task was an apprentice in our office when he enlisted, and we know him as an earnest student, a faithful, competent, prudent, spirited young man of good character and great industry and energy. Among the young men of our acquaintance, we do not know his equal. As soon as he enlisted he gave himself up to the study of his new profession, and after the Company officers came home from the Camp of Instruction could

describe (as he did with representative men and officers on a field marked out for the purpose) every movement to be made. He has always been popular with the Company, and we hope to see him confirmed in the position to which he is elected, as we believe him to be now fully qualified.

July 4, 1862 Paper The Michigan Sixth

A letter from the 6th Mich. Inf., dated Baton Rouge, La. June 3d, says:

"We are most comfortably quartered in the barracks here, said to be the best in the United States, being four great brick buildings arranged in horse-shoe form, with the open space toward the great river, which flows majestically by but a few rods from my window. There our long, low, black gunboats, with their big steam-pipes, ride at anchor ---- the terror of the whole secesh country far and near, and no vain terror that. Last week a guerrilla party galloped into town and fired their double-barrelled shot guns into a boat landing from one of the war vessels, wounding some of the Commodore's favorite men. Without a word of parley or a moment of delay, the big guns began to thunder on Baton Rouge and the brick and mortar began to fly. A bomb burst in a store; goods and building were literally gone up; fine houses staggered like a man stuck between the eyes. Men, women and children, white and black, with the lame, the halt and the blind for rear guard, ran in all directions for the woods, like rats leaving a burning barn ---- and to their horror, they found that on plantations more than two miles away, the long new fashioned shells from the great guns, had come down in fields ripping up the earth and killing cattle. The real intention was only to make a great scare --- and show people that they would all be held responsible for what guerillas do. The shot were aimed high, and although great stories of loss of life were told at first, we cannot find that anybody was killed. We were landed in the midst of the excitement.

This is certainly one of the most delightly places under the sun -- a most rich and fertile level country -- fine timeber -- the climate of Italy, the healthiness of the North. The idea that a northern man cannot work here is absurd, -- there are many men from the North about here who do work -- even as far South as the levee goes, white men, many of them Irishmen or German, are continually at work

with wheel-borrow and spade. Thousands of white men from the North and from foreign countries, are always at work in New Orleans. Yet the world has been made to believe that the cultivation of the earth, which nowhere yields more abundantly, or willingly, than here, is impossible except through that benificent institution which excludes Northern immigration, and of which not half the horrors will ever be told.

Capt. Fowler informs us that no man among the "Rifles" has been more active or useful to the service than Sergeant Samuel Pollock. While in New Orleans, he gained information from a contrabrand of the whereabouts of a large amount of Ammunition, deposited and secreted by the rebels. The Sergeant, with a detachment of men from the Rifles, made an examination of the place indicated by the contrabrand in the face of a large number of secesh gentry. Military stores to the value of \$100,000 were found, and from them the boats going up the river were supplied. He also, on another occcasion, discovered and turned over to the authorities, a full outfit for a military company. Before he left Charlotte, Sergeant P. was known as a prompt, energetic officer, and the actions above noted will satify the expectations of his friends.

The Rifles, since their return from Vicksburg to Baton Rouge, have been out on guard duty. At first 73 were unfit for duty, but letters say the men gained in health as soon as they left the

Sergeant Pollock was performing the duties of Orderly, but A. C. Whitcomb had been elected to the position.

Geo. E. Ranney. Ass't Surgeon of 2d Mich. Cav., was, at last accounts, lying very low in a hospital, at Cincinnati.

Peter Dow, the young man who was shot in the hand a year ago, and son of John Dow Esq. of Sunfield, died on the 22d ult. in hospital near Corinth.

Peter R. Johnson of Co. C. 2d Mich. Cav., has returned and procured a discharge, on account of ill health.

HOUCK ---- At his home in Carmel, on Friday October 21, 1892, of pneumonia and erysipelas. Mr. Wesley Houck, aged 54 years.

Mr. Houck was born in Seneca county, Ohio, from which place he came to Eaton county about twenty years since. He was an excellent citizen, honest and industrious and greatly respected as was attested by the presence of about six hundred friends at this funeral, which occurred Sunday at the Congregationalist church, Carmel. Rev. Watson officiating. There were present from out of the county his brothers Andrew, Isaac and Jeremiah from Ohio, Mr. and Mrs. S. F. Shumaker and L. C. and W. N. Shumaker, of Centreville; Mr. and Mrs. O. G. Tuttle, of Ithaca; I. J. Blair, of Elm Hall; and Jacob Shumaker and family, of St. Johns.

PERSONS ---- At the home of her daughter, Mrs. Warren Shaull, in this city, on Friday evening, of heart disease, Mrs. Phebe Persons, aged 60 years.

Mrs. Persons had assisted in doing the evening work and was in her usual health. She experienced some little difficulty in breathing, and took a dose of medicine to afford relief after which she lay down upon the bed and soon breathed her last. Mrs. Persons was possessed of one of those execeptionally sunny natures which endeared her to all who knew her. The funeral was held Monday, Rev. McAlpine officiating.

CASE ---- At the home of E. S. Tracey, on North Cochrane avenue, on Saurday, October 15, 1892, of typhoid pneumonia, and heart disease, Mrs. Delia Wheelock Case, aged 76 years and 11 months.

Mrs. Case was born in Batavia, New York, where she lived until 24 years ago when she came to this city with her brother-in-law Albert Parker, and family. She was a woman of unusual intelligence and she retained her interest in affairs up to the last. It was often remarked that she seemed much younger than her real age. She was a member of the Methodist church for more than fifty years. The

funeral took place at Mr. Tracey's residence at 2 o'clock on Monday, Rev. E. G. Lewis, assisted by Rev. H. S. Roblee, officiating. The remains were place beside those of her sister, Mrs. Parker, in Maple Hill cemetery. Miss Janet Winslow, of Leslie, a niece of Mrs. Case, attended the funeral.

SHEPARD ---- August 27, 1892, Edward B. Shepard, aged 80 years.

Mr. Shepard was born in Massachusetts March 8, 1912, and moved to Ohio with his parents when a small boy. In 1836 he married Betsey A. Bruce, of Carlisle, Ohio, who now survives him. In 1850 they moved to this state and settled on the farm where they have lived for forty-two years. Mr. Shepard lived a consistent christian, life and died a triumphant death. The funeral services were conducted by Rev. C. D. Jarvis.

DEWITT ---- At Grand Ledge, on Thursday, March 30, 1893, Jonathan DeWitt, aged 81 years.

Mr. DeWitt was universally respected wherever known. His wife whom he married 56 yers ago, survives him.

CAMPBELL --- At the county house, Chester, on Thursday, March 30th, 1893. Mrs. Archibald Campbell, age 80 years.

Her husband ran a foundry in this city thirty years ago.

MAXSON --- At her home in Randall, lowa, on Wednesday, September 28, 1892, of heart failure following rheumatism, Mrs. R. R. Maxson, aged 74 years.

Mrs. Maxson was the step mother of Roswell Maxson of this city. Her remains were brought to Roxand for interment and the funeral was held Sunday from the Maxson church, Rev. B. H. Mowers officiating.

BOTTOMLEY --- At her home in Charlotte, of cancerous tumor, on Wednesday, September 28, 1892, Mrs. Anna Bottomley, wife of Elijah Bottomley, aged 67 years 10 months.

The funeral was held Friday, Rev. E. G. Lewis officiating. Her sons, John and Henry Carey, of Texas and Wisconsin respectively, attended the funeral. Mrs. Bottomley had been a resident of Eaton county for nearly forty years and of this city for about ten years. She was a sufferer for

twenty years with the disease which caused her death.

MORGAN ---- .At her home in this city, on Sunday, October 2, 1892, after a short illness, Mrs. Hattie May Morgan, aged 32 years.

Mrs. Morgan was the only daughter of Freeman F. and Rebecca Parmeter, of this city. The funeral was held at the Universalist church at 3 o'clock yesterday. Hon. L. P. Moulton, of Grand Rapids, delivering the funeral address.

RILEY ---- At his home in Eaton, on Friday, September 30, 1892, John Riley, aged 82 years.

The funeral was held Sunday from the residence of H. O. Riley, conductd by Rev. F. McAlpine. Mr. Riley's death resulted from an injury received the day before while he was out in the field trying to catch some horses. As he was alone at the time and was too much injured to tell afterwards, the exact manner of the accident is a matter of conjecture.

ISHERWOOD ---- A his home in this city, of heart trouble and a cancer, on Thursday, September 28, 1892, Dr. William Campbell Isherwood, aged 69 years.

Dr. Isherwood was born at Rockdale, Pa. in 1823, and settled in Charlotte about thirty years ago. He leaves a wife and five children. The funeral was held Saturday afternoon at 3:30 o'clock, Rev. Snashall, of Grand Rapids, assisted by Rev. F. O. Dickey, of this city officiating. F. P. Isherwood of Toledo, Ohio, a brother of the doctor, and his wife, and M. D. Isherwood, of Chicago, and S. M. Isherwood, of Delpin, Indiana, were present at the funeral.

DICKINSON ---- At the home of his parents, North Washington street, on Friday morning, September 29, 1892, of consumption of the bowels, George A. Dickinson, only son of Henry L. and Mary F. Dickinson, aged 32 years, 11 months and \_\_\_ (?) days. (Can't read).

Mr. Dickinson was born at Sandy Hill, Washington county, New York, October 1, 1859, and nine years later settled with his parents in Benton and three years thereafter in Charlotte, where he has since lived highly esteemed by all who knew him. He united with the Baptist church about fifteen years ago and has always lived a right life. He was married September 30, 1879 to Miss Anna A. Wood who, with a 7 year old daughter, survives him. The funeral was held at 1:00 p.m. Saturday, the thirty third

anniversary of his birth, and was conducted by Rev. F. O. Dickey.

Page 156 CHESTER M. AMBROSE, one of the representative business men of Vermontville. where he is successfully established in the retail grocery trade, is a native of the old Buckeye state, having been born in LaGrange, Lorain county, Ohio, January 22, 1850, and being a son of David M. and Mary (Manville) Ambrose, the former of whom was born in Pennsylvania and died in LaGrange, Ohio, of typhoid fever, at the age of thirty-five years, while the latter, who was born in the state of New York, died in Vermontville, Michigan, at the age of sixty-two years. After the death of her first husband Mrs. Ambrose became the wife of Myron Bronson, who now resides in Hastings, Michigan. David M. Ambrose followed the vocation of farming, having been the owner of a farm in Lorain county, Ohio, at the time of his death. Of his three children, the subject of this sketch was the first born. George D. resides in Hastings, Michigan, and Frank F. makes his home in Vermontville. Of the second marriage of the mother was born one son, Fay, who resides in Hastings. Chester M. Ambrose secured his educational discipline principally in the public schools of Vermontville, to which place his mother and stepfather removed from Ohio when he was a child. At the age of sixteen years he left home, and for two years he was employed a salesman in the mercantile establishment of W. H. Benedict. of Vermontville, while for the ensuing three years he held a similar position in the store of the firm of Barber & Martin, and then was with H. J. Martin two years. At the age of twenty-five years he became a member of the firm of Barber, Hull & Ambrose, engaged in the general merchandise business, and later the firm title, by a change in one of the interested principals, became Barber, Ambrose & Rockwell, and finally Barber & Ambrose. Messrs. Barber and Ambrose continued to be thus associated until 1900, when Mr. Ambrose disposed of his interest and purchased the grocery business of

W. H. Benedict, having a well equipped and attractively appointed establishment and catering to a large and representative patronage. He is the sole proprietor of the business. Mr. Ambrose had been a supporter of the cause of the Republican party until 1896, when he manifested the courage of his convictions by aligning himself as an advocate of the free-silver policy, voting for Bryan for president and having himself elected county treasurer on the ticket of that year, holding the office two years and giving a most satisfactory administration of the fiscal affairs of the county. Aside from this office he has held no other save that of township clerk. In political matters he now stand quite independent of partisan domination or influence, voting in accord with the dictates of his judgment, both in national and local affairs. He is identified with the Masonic fraternity, and he and his family attend and support the Congregational church. Mr. Ambrose is held in high regard in the community, is known as a reliable and enterprising business man and as a citizen of utmost loyalty. In 1875 Mr. Ambrose was united in marriage to Miss Jessie L. Kenedy, who was born in Pennsylvania, being a daughter of Talma R. Kenedy, who was for many years a prominent farmer of Vermontville township, where he remained until his death. His wife, whose maiden name was Helen M. Tanner, still resides with her son, Durward R., on the old homestead, which is one of the valuable farms of Eaton county. Mr. and Mrs. Ambrose have two children. Agnes V. was graduated from the conservatory of music of Olivet College, as a member of the class of having gained the highest of endorsement from the faculty by reason of her superior talent and proficiency in music. Harry L., who held for four years a clerical position in the Merchants' National Bank of Charlotte, is now associated with his father in conducting the grocery business, being one of the popular young business men of Vermontville.

GRANGER F. ANSON -is one of the best known and most highly esteemed citizens of the village of Bellevue, where he has maintained his home for many years, and where he has been agent for the National Express Company and manager of the Citizen's Telephone Company until January 1, 1906, when he resigned. Mr. Anson is a native of the old Empire state of the Union, having been born in Canandaigua township, Ontario county, New

York, March 26, 1837, and being a son of Daniel B. and Maria R. (Rumsey) Anson. His father was born in the state of New York and died in Bellevue, Michigan, in 1894, having been more than eighty years of age at the time of his demise; his wife likewise was born in the state of New York and passed the closing years of her life in Bellevue, Michigan, where she died in March, 1880.

Daniel B. Anson was identified with agricultural pursuits in the state of New York until 1854, when he came to Michigan, locating in Bellevue township, Eaton county, in October of that year. Here he followed the trade of carpenter until within a few years of his death, having been a successful contractor and builder and having retired from active labor only when the results of an accident rendered him physically incapacitated. Of his five children the subject of this sketch was the first born; Anna died in childhood, prior to the removal of the family from New York; George R., who was a soldier in the Eighth Michigan Cavalry in the civil war and who is now a resident of Dunsmuir, California, married Savilla Hallawell, and they have three daughters; James L. who is a resident of the village of Bellevue and who is a carpenter and builder by vocation, married Lellie Weatherbee, and they had two sons, --- Daniel B., who has recently completed a service of three years in the United States army, having been stationed for some time in the Philippine islands, and Benjamin H., who died in the summer of 1905, at the age of seventeen years; Alonzo B., the youngest of the children, died in early Granger F. Anson secured his childhood. preliminary education in the schools of Rochester and Irondequot, New York, and after the removal of the family to Michigan he continued his studies in the district school near his home. After leaving school he clerked in a general store and in the postoffice at Bellevue, and later went to Pawpaw, Van Buren county, where he was employed in a drug store for six months, at the expiration of which, in September, 1864, he there enlisted in Company B, Twenty-eighth Michigan Volunteer Infantry, with which he proceeded to the front, taking part in the battle of Nashville, Tennessee, and in the engagement at Wise's Forks, North Carolina. He was taken ill and was confined in hospital at Morehead, North Carolina, until September, 1865, when he received his honorable discharge, on account of his physician's certificate of his physical disability.

After returning home he continued in impaired health for some time and was finally accorded appointment as assistant postmaster at Bellevue, while later he was appointed postmaster, retaining this incumbency thirteen years and resigning the office in 1884. The greater portion of the time since that he has been the Bellevue agent of the National Express Company. In 1894, however, he removed to Kalamazoo, where he remained four and one-half years, engaged in settling the estate of a relative. In 1898 he returned to Bellevue and in the following year he again took charge of the office of the Nation Express Company, in whose employ he has since continued, while he also ably managed the local affairs of the telephone company mentioned in the opening lines of this article, until his resignation. In politics Mr. Anson has been identified with the Republican party from the time of attaining his legal majority, having cast his first presidential vote for Abraham Lincoln. He served two terms as a member of the board of trustees of the village of Bellevue. He is identified with the Grand Army of the Republic, the Knights of Pythias, and the lodge and encampment of the Independent Order of Odd Fellows. Both he and his wife are zealous and valued members of the local Methodist Episcopal church. December 31, 1865, Mr. Anson was united in marriage to Miss Nancy C. Walrath, who was born in Ohio and who died in Bellevue, in March, 1881, leaving no children. He later wedded Miss Maria Keys, who was born in Calhoun county, this state, and who died in Kalamazoo, May 19, 1897, without issue. In June, 1898, Mr. Anson married Miss Emma F. Sears, who was born in the state of New York. They have no children.

One Hundred and Eighty
Dollars worth
of Buttons in Andersonville.

Submitted by Mary Jean Baker

We have read about and known of a great many Yankee inventions for the purpose of deceiving the "rebs" and retaining valuables that soldiers might be so unfortunate as to have about them at the time of their imprisonment, but the one I am about to relate is ahead of anything ever

brought to my notice before.

At the opening of the campaign of 1863 a portion of the 3d Michigan Inf. were captured and hurried away to that loathsome and dreaded prison-hold-Andersonville. Among them was the subject of our narrative, Willard Olds. Just previous to the capture the reg't had received its pay, and for some reason Mr. Olds had failed to express his money home, as most had done. It so happened that the capture occurred quite late in the afternoon,, and the rebs soon after went into camp. About midnight, when none were awake save the guard, Mr. Olds took from his knapsack an old ragged blouse (which he was so fortunate as to possess) and ripped from it the buttons, which were hollow on the inside. Opening them all in turn, he deposited in each two or three bills, by wadding them as closely as possible, until he had the buttons of that old dirty, ragged blouse, amount of one hundred and eighty dollars. Early the next morning every Yank was searched from head to foot, his pockets picked, etc. Mr. Olds was searched, his empty pocket book taken from him, a good clean blouse taken

off his back; but no one wanted the ragged old affair which he was allowed to retain in peace. By taking out and using in quantities so small as not to excite suspicion, he managed to keep not only himself but a number of his more needy fellows from utter starvation and the pangs of hunger experienced by so many in that loathsome place. A number of those whom he thus befriended live in this vicinity and can willingly testify to the truth of this statement.

I reside on Lansing street in the City of Charlotte Eaton County, Michigan. I am a married man. I am 35 years of age. I reside in a house on Lansing street. About the third of this month I was away from home. From Friday afternoon till Monday afternoon. I have four children. One of them had a child's bank in the house. During the time that I was gone some one opened that bank and took out all of the money. There was between a dollar and a quarter and a dollar and a half It was taken from my taken out. dwelling house there. It was in pennies and nickles and ten cent pieces and one quarter. I discovered the loss of it soon after we got home Monday afternoon. I spoke to the respondent about the matter that evening. In the first place he said he knew nothing about it. Then he admitted being in the yard and then admitted being in the house. He said that there was another

boy with him. He said Frank Parr was with him. We had a long talk and during that talk he finally admitted that he done it alone. He told me that he bought a ball club and ball with the money.

#### By The County Agent.

When I left home I took all my children away from the house. The house was fastened on the inside and when we left it we went out through the window. The window as not fastened down. I could see the window when I was returning home and see that it was open before I got to the house. My oldest child is eleven years old. He stayed at my father's. Father lives a mile or more from the house. This child and his cousin was at the house on Sunday and discovered that his money was gone.

And the said Horace S. Maynard upon his oath aforesaid says.

I am the Prosecuting Attorney in and for the County of Eaton. A few days ago the mother of the respondent called on me and desired to make a complaint against the respondent because of this affair and gave me information that he had been in several criminal affairs of late and that she had lost control of him and could not do anything with him: And I refused to have anything to do with it unless Mr. Sawyer would come and make the complaint. I told her that if she would call on Mr. Sawyer and have him come up and make the complaint I would

send for the County Agent and we would investigget the case and the County Agent would direct what would be best to have done about it. A short time after that Mr. Sawver came and made the complaint in the case. I have seen the respondent today questioned him about this matter and he says he went into the house several times. That he took part of the money the first time that he was in and came up town and spent it, then went back and obtained some more. He gave me an account of where he had spent the money and I went with him with the County Agent to some of the places and their account agrees with his. One man, Mr. Foote, proprietor of the drug store doesn't recollect of his coming But the respondent says he bought a ball there which he now has at home but his mother does not know of it. He has enumerated articles which he bought with the money which he procured there to come to some fifty or sixty cents, but says he bought candy and such things several times and don't know how much he did spend. He has stated to me that when he went into the house there were two other boys with him. That a boy by the name of Frank Parr took the money out of the bank and gave

him the quarter of a dollar, which was in the bank if he, the respondent would not tell. He also says that another boy by the name of "Gus" Rhefus was with him and that the three went into the house one night after dark and were also in the house in the day time. Respondent says they raised the window and crawled into the window. He insisted upon it at first that a quarter was all the money which he had from the bank and that was all in one piece but the merchants say that

he paid them in nickles and he says so too, for at least a part of the stuff. And the amounts which he says he paid at the stores come to more than the twenty five cents.

He told me he had cleaned out gutters and spit-boxes for the I had not given him any money. monev. Lately he has been talking roughly to me. He has lately used profane language.

I went to Mr. Sawyer or rather saw Mrs. Sawyer and left word there that the Prosecuting Attorney said that if he would come up and make complaint, he would take it.

Henry Gardner May 15, 1844 Jan. 28, 1934

Henry Gardner was born in New Haven, Huron county, Ohio, on May 15, 1844, and passed on Sunday, Jan. 28, 1934, at the age of 89 years, 8 months and 13 days. He came to Michigan when a boy of twelve and spent the rest of his life in or near Charlotte, with the exception of a term of enlistment in the union army during the Civil war. He enlisted at the age of 19 in Company I, 2nd Michigan Cavalary and served to the end of the war. Mr. Gardner was married in August 4, 1867, to Miss Mary Bracy by whom he is survived. To this union were born five children, Lewis E., Hattie M., Minnie, Pearl, and Henry E. All but Hattie who died in infancy survive the father. Mr. Gardner has 14 grandchildren and great-grandchildren. He is survived. also, by a brother, George F. Gardner, who is 87 years old. Mr. Gardner was a most kind and loving husband and father and leaves a host of friends who mourn his passing.

The funeral service was held at the Cheney funeral home at 2:00 on Tuesday afternoon. Rev. R. W. Roth of the Congregational church officiated.

Carl T. Church, President of the Merchants' National Bank, of Charlotte, has been prominent in the history and affairs of Eaton County for a period of nearly forty years. In every good work of a public nature during that time, in both city and county, his name is inseparably connected, in numerous cases his personality is stamped upon it. His natural talent as a financier and adviser, together with his broad and progressive public spirit, have been potent in the development of this locality, and are still largely directing the forces which enhance its welfare. Mr. Church comes from one of the pioneer families of Ohio. He was born in Sencca County, of that State, January 26, 1835. His parents were Earl and Calena (Titus) Church. His mother was a daughter of Curtis Titus, and was born in February, 1808, in Connecticut. She was a type of the noble self-sacrificing women who having capacity and endurance were such important factors in settling up the great Northwestern Territory in the first part of this century. To her constant care and activity in their behalf her family owned much in the of comfort and happiness in their pioneer home. She was an expert in the use of the spinning wheel, and while the meals were being cooked before the fire in a huge open fire-place her hands were spinning the yarn to clothe the family.

The father was born January 28, 1798, in Saratoga County, in the State of New York, and married June 14, 1827. He resided in Castile, Genessee County, until 1833, when he removed with his wife and three children, to the primeval wilds of Ohio. After a short

residence in Huron County he located among the pioneers of Seneca County, buying a tract of Government land in Adams Township. His first work was to erect a log cabin for the shelter of his family, which was the regulation pioneer abode of the times, with a chimney of earth and sticks, the fireplace occupying rhe greater part of the one end of the house, and logs six feet long being burned in it. It was in such an humble abode, surrounded by the earliest pioneer environments, that the subject of this sketch was born. The surrounding country was a mere wilderness, with but few evidences of civilization, there being no railroads in that section for many years after, the lake ports being the nearest markets. The father was a man of superior mental calibre, who had been well educated, and his services were sought as a pioneer teacher in Seneca County. In the month of August, 1849, death rounded out his life, and the community was deprived of an honored citizen who left behind him a record unblemished, and the memory of an upright man who had been true in all the relations that he had sustained toward others. He and his worthy wife were the parents of eight children, viz: Daniel W., Lucinda, John C., Earl T., Eleanor, Harvey W., Anna and Charles C., our subject being the fourth.

During his youth Earl T. worked on the farm in the summer and attended school in the winter, his first instruction being received in a school taught by his father. After his father's death he made his home with his uncle, by whom he was employed as a farm laborer until he was seventeen years old. At that time he entered the mercantile world as a clerk in a store at Fremont, in his native State. A year

following he gave up that position and decided to try his fortune in the Golden State, but while on his way was taken sick at St. Joseph, Mo., and was compelled to abandon the trip further. Returning to Ohio, he remained a short time and in the fall of 1854 cast in his lot with Michigan, and has ever since been a resident of Charlotte. Upon arriving here his time was employed in various kinds of work, clerical and otherwise, besides a course of study in the academy and serving as clerk in the office of County Register of Deeds for three years.

in 1858 M. Church embarked for himself in business, and a continuous chain of active business life follows that venture to the present hour. He opened a small grocery store which he stocked with goods amounting in value to \$300, selling a part of his home lot in part payment, while owing at the same time \$400 in a mortgage upon his home. His capacity and integrity as developed drew to him the best people of village and country, and from that time until 1881 he gave his pricipal attention to the details of his business, and became locally celebrated for the purity of the goods he sold and his careful attention to the wholesome wants of his customers. Upon this question of absolute integrity in the details of his business relations, he was always noted. Never would he permit even the smallest value to be paid for poor goods in his store when he knew it, preferring rather, when necessary, to destroy them and suffer the loss himself. He was a natural enemy to adulterations in goods as well as in character, and people soon learned that it was not necessary to question the purity of goods or accuracy of accounts when dealing in his store. Since 1881 he has remained

with the business only as a silent partner, but it is yet one of the largest and finest establishments of the kind in Eaton County.

In December, 1884, Mr. Church was requested by a few of the stockholders of the Merchants' National Bank to interest himself with them, as his ability and experience were needed in the counsels of that corporation. His consent was obtained, and in May, 1886. he assumed the active of this management prosperous institution, and has continued as President and manager since that time, executive ablility, careful and conservative movements, with good judgment added, have no-where been better evinced than in his connection with this bank in the responsible position he occupies as its presiding officer, as under his careful and skillful guidance it has become one of the foremost monetary institutions in this part of the State, its prosperity resting on a sound and healthy basis, and enjoying the full confidence of its depositors and all who have dealing with it.

But President Church does not lose the spirit of his first love, as he finds time for recreation in looking after farm work, in the midst of his other duties, summer devotes and everv considerable attention to his farms and agricultural interests. He is further identified with the financial interests of the people, as he loans money for non-residents and others, and is prominently connected with various enterprises which have been started from time to time for the furtherance of the interests of city and county.

He assisted in organizing the Charlotte Manufacturing Company, and was elected its President in 1873, which position he has held ever since.

When the Eaton County Agricultural Society was organized he took an active interest in it, and the society is greatly indebted to him for his untiring zeal in its welfare. He has served repeatedly in past years as Secretary and President of this association, and the beautiful grounds are largely due to the energy of Mr. Church, who led squads of volunteer laborers day after day, from year to year, in fitting and beautifying the same for its present era of usefulness and profit to the people of the county. Mr. E. S. Lacey, (present Comptroller of the Currency) speaking in one of his reports of the extensive improvements that had been made in grove, said "nineteen-twentieths of the credit was due to the unfaltering zeal, the indomitable energy, the systematic effort, and faultless taste of Mr. Church."

During the war he was Enrolling Commissioner and Recruiting Agent for his town, and his usual zeal was present in keeping up the required quota of men, and in many other ways his devotion to the Government was made manifest. The Eaton County Jail, one of the best in the State, was erected under his and Mr. Lacey's Mr. Church supervision, being Chairman of the Building committee, and a remarkable fact is recorded that it was built for a less sum than was appropriated for that purpose. His city is greatly indebted to him for its fine public library, as he was very active in securing its establishment, was for many years its President, and still takes a deep interest in it. He is also a moving spirit in the Charlotte Cemetery Association. and has been President since 1873.

In politics Mr. Church is a Democrat, but inclined to the broad and advanced

ideas of a fraternal Nationalism. He is thus not wedded to party issues regardless of where they lead. He is too broad and honest for a first-class modern politician. When twenty-one years of age he was elected Town Clerk and held that position many years, and in 1868 was advanced to Supervisor, and re-elected year thereafter until Charlotte was incorporated as a city. He was elected the first Treasurer of Charlotte and handled the public funds until 1871. when he was elected President of the village, which was incorporated as a city that year. He was Chairman of the committee that drew up the city charter and procured its adoption. Under this charter he was elected its first Supervisor, and the following year was advanced to the Mayoralty. In 1872 he was the candidate of his party for the Legislature, and although defeated ran beautifully ahead of his ticket.

Mr. Church is a prominent Mason, and has filled the position of district Deputy Grand Master of the fifth Masonic district, embracing Jackson, Calhoun, Barry and Eaton counties. He has filled the chair of Master in Charlotte Lodge several years, and was elected the first High Priest in the Chapter. He is now Treasurer of his commandery of Knights Templar, and presiding officer of the Council.

To the lady who presides over his home and unites with him in extending its hospitalities, Mr. Church was married in August, 1856. Mrs. Church's maiden name was Emma J. Bouton, her parents being pioneers of Eaton County. This union brought them one son, Charles E., who now resides in Kansas City. With all of the public work and duties to which Mr. Church has been called he has always preserved the quiet, unassuming and

modest deportment natural to him. He worked for results rather than personal aggrandizement or glory. He is not ambitious as the world knows ambition, yet is untiring in his devotion to all matters pertaining absolutely to the public good. He belongs to that great minority who seek to do right in all things because it is right, without making inquiries about rewards or punishments, therefore he could not be other that liberal in his religious convictions. His personal sorrows and griefs are always borne silently and alone, and we might say his joys also, as he does not seek to be seen and known of men except so far as good can be produced from it. While he has not amassed a large fortune, or attained great distinction, as the world usually measures men, he has done what is more in keeping with his character; been a cheerful giver, an earnest worker for his fellows, ever modestly working out his destiny with truth upon his banner, and he already enjoys the reward of his good works by securing the unbounded confidence of his fellow-citizens.

There is no time frame required to complete the course. A student could conceivable finish the course in less that twenty-four hours due to a feature called Speedback. Speedback assignments submitted on the course website receive instant feedback.
